If a notice of approval is later returned undelivered, registrars must proceed with confirmation of voting residence notice under CGS § 9-35 or § 9-43 and may challenge applicant at polls. DECEMBER 1, 2021 (Wednesday) <u>REGISTRARS / TOWN CLERK</u>	<u>POLLING PLACE ADJACENT DISTRICT TOWN COMMITTEE PRIMARIES</u> . Last day for registrars, when necessary, to designate to the town clerk a polling place in an adjacent voting district for <u>town committee</u> primary. Within 10 days after such filing, town clerk to publish notice. (§ 9-168b)
DECEMBER 1, 2021 (Wednesday) LEGISLATIVE BODY	<u>VOTING DISTRICTS – TOWN COMMITTEE PRIMARIES</u> . Last day to make changes in the boundaries of voting districts for <u>town committee</u> primary. (§ 9-169) Note: 90 day requirement does not apply in a year of redistricting (§9-169b).
DECEMBER 29, 2021 (Wednesday) <u>TOWN CHAIRMEN</u>	<u>NOTICE OF CAUCUS – TOWN COMMITTEE PRIMARIES</u> . Last day to publish notice of <u>town</u> <u>committee</u> endorsement caucus, if caucus held on <u>January 4<sup>th</sup></u> . If caucus is held <u>January 11<sup>th</sup></u> , then <u>January 5<sup>th</sup></u> is last day. Notice must be published at least five full days before the caucus. Party rules may require earlier notice. (§ 9-390)
DECEMBER 30, 2021 (Thursday) <u>REGISTRARS</u>	<u>WAIVER OF ACCESSIBILITY OF POLLING PLACE – TOWN COMMITTEE PRIMARIES</u> . Last day that registrars may file with the <u>local building official</u> a request for a waiver to provide accessible polling place for physically disabled, for <u>town committee</u> primary. (§ 9-168d)

JANUARY <u>REGISTRARS</u>	<u>PERMANENT ABSENTEE BALLOT NOTICE</u> . JANUARY 1, 2022 thru APRIL 30, 2022 (Saturday - Saturday) <u>REGISTRARS</u>	<u>CANVASS</u> . JANUARY 4, 2022 (Tuesday)	<u>NOMINATING PETITION FORMS - ELECTION</u> . Secretary of the State may begin issuing nominating petition forms for offices to be contested at the regular election. (§ 9-453b)
JANUARY 4, 2022 to JANUARY 11, 2022 (Tuesday - Tuesday)	<u>PARTY ENDORSEMENT – TOWN COMMITTEE PRIMARIES</u> . Endorsement for <u>town committee</u> members by caucus between these days. (§§ 9-390 and 9-391)
POLITICAL PARTIES / REGISTRARS	<u>PRIMARY PETITIONS AVAILABLE – TOWN COMMITTEE PRIMARIES</u> . Petition forms for persons desiring to oppose party-endorsed candidates for <u>town committee</u> must be available from the registrar of voters beginning on the day following the making of the party's endorsement of candidates for <u>town committee</u> or beginning on the day following the final day for the making of such endorsements, whichever comes first. (§ 9-409)
JANUARY 11, 2022 (Tuesday) <u>POLITICAL PARTIES/REGISTRARS</u>	DIRECT PRIMARY FOR TOWN COMMITTEE. In the case of any municipality having a population of one hundred thousand or more and in which a party by its rules provides that the town committee members of such party be chosen at direct primaries, if, by four o'clock p.m. on the forty-ninth day preceding the first Tuesday in March in even-numbered years, the number of persons who have requested petition forms for candidacies for election as members of such town committee and filed a signed statement consenting to be a candidate for such position is equal to or less than the number of town committee members to be elected by such party, but at least twenty-five per cent of such number then (1) the requirements regarding such persons' filing of candidacies for election using signed petitions shall not apply, (2) the requirements regarding the registrar's receipt of petition pages and certification of signatures on such pages shall not apply, and (3) no primary shall be held by such party for town committee members and such persons shall be deemed to have lawfully been elected to such positions.
JANUARY 12, 2022 (Wednesday) 4:00 p.m. <u>POLITICAL PARTIES / TOWN CLERK</u>	<u>PARTY ENDORSEMENTS – CERTIFICATION – TOWN COMMITTEE PRIMARIES</u> . Last day for the chairman or presiding officer <u>OR</u> the secretary of the caucus to certify to the town clerk the names and street addresses of party-endorsed candidates for <u>town committee</u> . Clerk must forthwith publish notice of certification and that list of candidates is on file. (§§ 9-391 and 9-395)
JANUARY 21, 2022 (Friday) <u>POLITICAL PARTIES</u>	<u>PARTY RULES – DELEGATE SELECTION</u> . Last day to file with the Secretary of the State change in party rules regarding the method of party selection for candidates to be selected as <u>delegates</u> if selection is made on <u>March 22, 2022</u> . If endorsement is made on <u>March 29, 2022</u> , then <u>January 28, 2022</u> is last day. At least sixty days before selection, one copy of party rules governing such selection must be filed with the Secretary of the State. One copy of revised local party rules (and any amendments thereto) must also be filed forthwith with town clerk and state central committee. (Applies only when new rules are adopted or existing rules are amended or rescinded.) (§§ 9-374 and 9-375)
JANUARY 26, 2022 (Wednesday) 4:00 p.m. <u>REGISTRARS</u>	<u>PRIMARY PETITIONS – FILING - TOWN COMMITTEE PRIMARIES</u> . Primary petitions for opposition candidates for <u>town committee</u> must be submitted to respective registrars by 4:00 p.m. of this day. Registrar of voters, deputy registrar or assistant registrar must be in their office or office facilities between 1:00 p.m. and 4:00 p.m. to accept petitions. (§§ 9-405 and 9-406)
REGISTRARS TOWN CLERK	<u>NOTICE OF PRIMARY – TOWN COMMITTEE PRIMARIES</u> . On filing of valid petition for <u>town</u> <u>committee</u> , and after checking the same, registrar notifies town clerk that primary is to be held and clerk publishes registrar's notice and information concerning candidates, primary date, hours and location of polls, files one copy with Secretary of the State, and records said notice. If central counting designated by registrars, the notice of primary shall include such central location. (§§ 9-147a and 9-435)

TOWN CLERK	<u>PRINTING ABSENTEE BALLOTS – TOWN COMMITTEE PRIMARIES</u> . Immediately after the deadline for the certification of all <u>town committee</u> candidates whose names are to appear on the ballot, the town clerk must begin making arrangements to have the primary absentee ballots printed. (§ 9-135b(a))
TOWN CLERK	<u>SAMPLE ABSENTEE BALLOT AVAILABLE – TOWN COMMITTEE PRIMARIES</u> . A layout model of each different absentee ballot shall be available for public inspection at town clerk's office prior to printing. (§ 9-135b(b))
TOWN CLERK	<u>ABSENTEE BALLOTS – FILING – TOWN COMMITTEE PRIMARIES</u> . Immediately upon receiving the printed absentee ballots for <u>town committee</u> primary, municipal clerk must file a printed absentee ballot for the municipality or for each different political subdivision, as the case may be, with Secretary of the State, and file an affidavit as to number of such ballots printed. (§ 9-135b(c))
TOWN CLERK	BLANK BALLOTS TO ELECTORS TEMPORARILY LIVING (OR EXPECTING TO BE TRAVELING) OUTSIDE U.S. AND TO SERVICEMEN, SPOUSES AND DEPENDENTS WHETHER LIVING WITHIN OR OUTSIDE U.S – TOWN COMMITTEE PRIMARIES. Beginning as soon as possible after a complete list of candidates is available, blank ballots (for the <u>town committee</u> primaries), together with a complete list of candidates, should be sent to electors residing (or expecting to be traveling) outside the United States and to servicemen, spouses and dependents whether living within or outside the United States who have applied for an absentee ballot and are eligible to vote in the primary. (§ 9-153f)
<u>REGISTRARS</u>	Registrars may direct the clerk to mail such blank ballot set to a qualified elector or applicant for admission as an elector who (1) is living outside the U.S. or (2) is a member of the armed forces, spouse or dependent. Town clerk also may so act on his own motion. (§ 9-153d)
JANUARY 26, 2022 to FEBRUARY 22, 2022 (Wednesday - Tuesday) INSTITUTIONAL ADMINISTRATORS AND REGISTRARS	<u>SUPERVISED BALLOTING DESIGNATION – TOWN COMMITTEE PRIMARIES</u> . In order to have supervised absentee balloting in a nursing home or rest home, etc., with fewer than 20 electors, a written designation must be made between these dates by either registrar of voters or the administrator of the institution for the <u>town committee</u> primary. These deadlines do not apply to a nursing home or rest home, etc., with 20 or more electors because supervised voting is mandated at such institutions. (§§ 9-159q and 9-159r)
JANUARY 28, 2022 (Friday) <u>REGISTRARS</u>	<u>POLLING PLACES – PRIMARY – TOWN COMMITTEE PRIMARIES</u> . Last day to determine polling places for <u>town committee</u> primary. Polling places may be changed within thirty-one day period only if town clerk and registrars of voters unanimously find that polling place has been rendered unusable. If polling place found unusable, another polling place must be designated forthwith and adequate notice of such change given. (§§ 9-168 and 9-169)
JANUARY 28, 2022 (Friday) <u>REGISTRARS</u>	<u>CERTIFICATION OF LOCATION OF POLLING PLACE – TOWN COMMITTEE PRIMARIES.</u> The registrars of voters shall certify to the Secretary of the State the location of each polling place that will be used at the <u>town committee</u> primary. The certification shall detail the name, address, relevant contact information and corresponding district information associated with each polling place to be used. Such report shall also include the names and addresses of each moderator for each polling place listed on such report. (§9-228a)
JANUARY 31, 2022 (Monday) <u>TOWN CLERKS</u>	<u>SECURE DROP BOX</u> – Beginning on the twenty-ninth day before each election, primary or referendum, and on each weekday thereafter until the close of the polls, the municipal clerk shall retrieve from the secure drop box each such ballot deposited in such drop box.

FEBRUARY 6, 2022 to FEBRUARY 12, 2022 (Sunday - Saturday) <u>TOWN CLERK</u>	REPORT TO SECRETARY OF NUMBER OF TABULATORS. Town Clerks shall notify the Secretary of the State during the first week of February in each year of the total number of tabulators, by district, in such town. If the number of tabulators is less than the number required under § 9-238, the town clerk shall include an explanation of the discrepancy. Each town clerk shall also file a duplicate copy of such notification with officials who are required to provide tabulators under § 9-238. (§ 9-238a)
FEBRUARY 8, 2022 to FEBRUARY 24, 2022 (Tuesday - Thursday) <u>REGISTRARS</u>	REGISTRATION BY MAIL TOWN COMMITTEE PRIMARIES NOTICE OF ACCEPTANCE OR REJECTION TO BE SENT ON DAY OF RECEIPT. When an application for registration by mail is received during the period beginning on the 21st day before a primary and ending on the fifth day before a primary, registrar must send by first-class mail a notice of acceptance or rejection on day of receipt of application. The privileges as an elector attach immediately upon approval of the application, and the new elector's name is added to the registry list. If a notice of approval is later returned undelivered, registrars must proceed with Confirmation of Voting Residence Notice under CGS §§ 9-35 or 9-43 and may challenge applicant at polls. (§ 9-23g(c) and (d))
FEBRUARY 8, 2022 (Tuesday) <u>REGISTRARS</u> <u>TOWN CLERKS</u>	<u>CERTIFICATE OF BALLOT ORDER – TOWN COMMITTEE PRIMARIES.</u> The registrars of voters and municipal clerk shall jointly certify to the Secretary of the State the number of ballots for each polling place in the municipality that have been ordered for the <u>town committee</u> primary. If the registrars of voters and municipal clerk fail to certify the number of ballots ordered, they shall order a number of ballots equal to the total number of registered voters in their municipality. (§9-255a)
FEBRUARY 8, 2022 (Tuesday) <u>CANDIDATES</u>	<u>LIST OF MODERATORS – TOWN COMMITTEE PRIMARIES</u> . Last day for candidate to submit to registrars list of desired certified primary moderators for <u>town committee</u> primary. Registrar must notify all candidates of their right to submit a list of designees. (§ 9-436)
FEBRUARY 8, 2022 (Tuesday) <u>REGISTRARS / CANDIDATES</u>	<u>LIST OF PRIMARY OFFICIALS – TOWN COMMITTEE PRIMARIES</u> . Last day for candidates to submit to registrar lists of desired primary day officials, except moderators, for <u>town committee</u> primary. Registrar must notify all candidates of their right to submit a list of designees. (§ 9-436)
FEBRUARY 8, 2022 (Tuesday) <u>REGISTRARS</u>	<u>CENTRAL COUNTING ABSENTEE BALLOTS – TOWN COMMITTEE PRIMARIES.</u> Last day for registrars to designate in writing to the town clerk central location for the counting of absentee ballots for <u>town committee</u> primary. Such location shall be published by the town clerk in the notice for the primary. The Registrars of Voters can also agree to count absentee ballots at each polling location. (§ 9-147a)
FEBRUARY 8, 2022 (Tuesday)	<u>ABSENTEE BALLOTS – TOWN COMMITTEE PRIMARIES</u> . Absentee ballots for town committee primary become available on this day. (§§ 9-135 and 9-140(f))
TOWN CLERK	Registrars of voters may direct town clerk to mail absentee ballot forms to a qualified elector or applicant for admission as an elector who (1) is living outside the U.S. or (2) is a member of the armed forces or the spouse or dependent of a member of the armed forces living where such member is stationed. Town clerk also may so act on his own motion. (§§ 9-133f, 9-140(f) and 9-153d)
FEBRUARY 15, 2022 (Tuesday) <u>REGISTRARS</u>	<u>PRIMARY ENROLLMENT SESSION – TOWN COMMITTEE PRIMARIES</u> . If primary is to be held, mandatory enrollment session must be held on this date (14th day before primary) for the purpose of registration and/or enrollment of electors entitled to vote in <u>town committee</u> primary. At least two consecutive hours required, between the hours of 12:00 noon and 9:00 p.m. (§ 9-51)
	If primary is to be held, registrars must also hold a session to hear requests for adding names to the registry list by persons removed. This session may be held simultaneously with the enrollment session. (§ 9-37)
REGISTRARS	ENROLLMENT LIST. The registrars shall cause to be printed at least once during the calendar year a complete enrollment list and shall make such list available to the public upon request. (Sec. 9-55)

FEBRUARY 22, 2022 (Tuesday) <u>REGISTRARS</u>	<u>ABSENTEE BALLOT CHECK-OFF TOWN COMMITTEE PRIMARY</u> . Whether central counting of absentee ballots has been designated or not, beginning as soon after 11:00 a.m. as the absentee ballots are available from the town clerk, the registrars <u>may</u> begin checking the absentee ballots on this day and each weekday before the <u>town committee</u> primary. The ballots <u>shall</u> be checked not later than the last weekday before the primary. The registrars shall check, without opening the outer envelopes, the names of such absentee voters on the official check list to be used at such primary by indicating "absentee" or "A" preceding such name, and in the case of central counting shall also note such designation on a duplicate list. After checking is completed, town clerk seals unopened ballots for delivery between 10:00 a.m. and 12:00 noon, primary day. (§ 9-140c)
FEBRUARY 22, 2022 (Tuesday) INSTITUTIONAL ADMINISTRATORS AND REGISTRARS	<u>SUPERVISED BALLOTING DESIGNATION – TOWN COMMITTEE PRIMARIES</u> . Last day to request supervised absentee balloting in a nursing home or rest home, etc. with fewer than 20 electors. A written designation must be made by this date by either registrar of voters or the administrator of the institution for the <u>town committee</u> primary. This deadline does not apply to a nursing home or rest home, etc., with 20 or more electors because supervised voting is mandated at such institutions. (§§ 9-159q and 9-159r)
FEBRUARY 24, 2022 (Thursday) <u>REGISTRARS</u>	REGISTRATION AND ENROLLMENT CUT-OFF (BY-MAIL) – TOWN COMMITTEE PRIMARIES. Deadline for registering and/or enrolling for voting in <u>town committee</u> primaries unless register in person with town clerk or registrar or unless file application for enrollment in person with registrar of voters. (§§ 9-23g, 9-56 and 9-57)
	Mail-in application of new voter must be received by registrar of voters of the town of residence by this day, except that a mail-in application of new voter postmarked by this day or received by a voter registration agency or the Department of Motor Vehicles by this day may be received by the registrar of voters until 12:00 noon of <u>February 28, 2022</u> . (§ 9-23g(c) and (d))
	However, enrollment application of unaffiliated voter must be <u>received</u> by this day by registrar of voters of town of residence, unless unaffiliated voter files application for enrollment in person with registrar of voters by 12:00 noon of <u>February 28, 2022</u> . (§ 9-56)
FEBRUARY 25, 2022 thru MARCH 1, 2022 (Friday - Tuesday) <u>REGISTRARS</u>	REGISTRATION BY MAIL TOWN COMMITTEE PRIMARIES NOTICE OF ACCEPTANCE OR REJECTION TO BE SENT WITHIN 10 DAYS. PRIVILEGES OF AN ELECTOR SHALL NOT ATTACH UNTIL THE DAY AFTER THE PRIMARY OR THE DAY APPLICATION IS APPROVED BY REGISTRAR, WHICHEVER IS LATER. When a mail-in application hand-delivered by someone other than the applicant is received during this period by registrars in applicant's town of residence (or by the DMV or a voter registration agency), or a mailed mail-in application for registration is postmarked during this period, registrar must act on the application and send by first-class mail a notice of acceptance or rejection within 10 days of receipt of the application, but privileges of an elector shall not attach until <u>March 2, 2022</u> , or until the application is approved by registrar, whichever is <u>later</u> . **IMPORTANT EXCEPTION:** 

If an application indicates that it was received by November 1, 2022 by the DMV or a voter registration agency (or a special assistant registrar or town clerk or a registrar of voters of another town), the registrar of voters of the town of residence shall mail a notice of acceptance or rejection on the day of receipt of such application during this period. Such persons whose applications are accepted acquire privileges of an elector immediately and may vote in the election. (§ 9-23g)

NOVEMBER 2, 2022 <u>REGISTRY LIST - ELECTION</u>. Last day for registrars to file with the town clerk a final registry list (Wednesday) that contains the names and addresses of electors to be transferred, restored or added to such REGISTRARS list. Such list shall also be on file and available for public inspection in the registrars of voters office. Whenever the registrars of voters are not in their office, such list shall be available at another municipal office. (Sec. 9-38)

> UNOFFICIAL CHECKERS - ELECTION. Deadline for Town Chairmen or candidates (if gualified) to designate unofficial checkers to the registrars of voters. Registrar, at request of his town chairman, shall change appointments up to close of polls. (§ 9-235)

Any person (other than a candidate or election official) may serve as a runner. (Sec. 9-235b)

Unofficial Checkers for Questions: Registrars must notify (1) each committee and person on whose behalf a political committee statement of organization or a certificate of exemption has been filed for a guestion with the town clerk, and (2) each other group known to be for or against a referendum issue, of their right to submit designees to the registrars at least 48 hours before the opening of the polls, indicating their position on the question. (Sec. 9-235(e))

Session of Registrars of Voters of <u>ALL</u> towns to admit those seeking to vote in election whose qualification as to age, citizenship or residence was attained since <u>November 1<sup>st</sup></u> . Hours: 9:00 a.m 5:00 p.m. (§ 9-17)
NOVEMBER 7, 2022 (Monday) <u>REGISTRARS</u>	SUPERVISED BALLOTING DEADLINE - ELECTION. Supervision of absentee balloting shall be not later than the last business day before the election. (§§ 9-159q and 9-159r)
NOVEMBER 7, 2022 (Monday) <u>TOWN CLERK</u>	ELECTION MATERIALS. Registrars of voters to provide election materials to Moderators before 8:00 p.m. (§ 9-259)
NOVEMBER 7, 2022 (Monday) <u>REGISTRARS</u>	TABULATORS - ELECTION. Tabulators must be prepared and delivered to polling places with all necessary furniture and equipment not later than one hour prior to the opening of the polling place. (§§ 9-238 and 9-247)
NOVEMBER 7, 2022 (Monday) <u>TOWN CLERK</u>	<u>ABSENTEE BALLOTS. DEADLINE TO ISSUE - ELECTION</u> . Absentee ballots may not be issued on election day, except overseas ballots and except electors who suddenly become ill within six days immediately preceding the close of the polls at the election or who are patients in a hospital within such six-day period, may apply for and be issued an absentee ballot up to the close of the polls. (§§ 9-140(h) and 9-150c)
NOVEMBER 7, 2022 (Monday) <u>REGISTRARS</u>	<u>ABSENTEE BALLOT CHECK-OFF - ELECTION</u> . Whether central counting of absentee ballots has been designated or not, beginning as soon after 11:00 a.m. on this day as the absentee ballots are available from the town clerk, the registrars shall check without opening the outer envelopes, the names of such absentee voters on the official check list to be used at such election by indicating "Absentee" or "A" preceding such name, and shall in the case of central counting also note such designation on duplicate list. (DMV notifies the registrars, and the registrars send Notice of Removal.) The names of persons removed are not sent to the polls and such persons may be restored on election day only if both registrars are contacted and consent to approve the applicant's request for restoration. 	<u>INACTIVE LIST</u> . The registrars prepare an inactive list of (1) any person whose notice of approval of mail-in was returned undeliverable and who did not respond to a confirmation of voting residence notice sent thirty days prior to this date, and (2) any person who was sent a confirmation of voting residence notice between January, 2022—May, 2022 or between January, 2021 May, 2021 or between April, 2020May, 2020 or between January, 2019May, 2019 on the basis of the canvass and did not respond within thirty days after it was sent (and was not restored). The inactive list is sent to the polls. Electors on the inactive list may sign a restoration form at the polls and, if both registrars or both assistant registrars of voters in the polls consent, such elector may vote. (§§ 9-23g(c), 9-35 and 9-42(c))
	<u>REMOVE FROM INACTIVE LIST</u> . Last day before election to remove electors from inactive registry list who were sent a Confirmation of Voting Residence Notice four years ago and did not respond within thirty days after it was sent (and were never restored to the active list). (Sec. 9-35)

<u>VOTER REGISTRATION RECEIPT.</u> On election day, an applicant whose name is not on the checklist may vote if, at the polls, he (1) presents a voter registration receipt from the DMV or other prescribed voter registration agency that his application was received by the deadline, (2) fills out a new voter registration card, (3) the card is approved by the registrar, and (4) the voter presents the required identification. (§ 9-23g(d)).

<u>HOURS OF VOTING</u>. Polls to be open 6:00 a.m. to 8:00 p.m. Electors in line by 8:00 p.m. permitted to vote. (§ 9-174)

<u>OVERSEAS BALLOTS</u>. Overseas ballots may be issued up to the close of the polls. However, they must be received by town clerk by close of the polls on election day in order to be cast. (§§ 9-158c and 9-158g)

<u>ABSENTEE BALLOTS</u>. In order to be cast at an election, the absentee ballot must be received by the town clerk (1) by the close of the polls if it is mailed or if it is returned by a member of the immediate family of the applicant in person or by the qualified designee of an ill or physically disabled ballot applicant in person, or (2) by the day before the election if it is returned in person by the applicant. (§ 9-140b)

<u>ABSENTEE BALLOTS</u>. Absentee ballots are to be delivered to the registrars of voters between 10:00 a.m. and 12:00 noon, at 6:00 p.m. (optional), and again, immediately after the close of the polls. Those ballots which are timely received after 11:00 a.m. of the last weekday before election are to be delivered to the registrars of voters at 6:00 p.m. and/or 8:00 p.m. In municipalities which have central counting of absentee ballots, at close of polls, registrars or assistant registrars shall deliver official check list to central counting moderator. When counting of absentee ballots is complete, central counting moderator delivers check list, duplicate check list and returns required by Sec. 9-150b to head moderator. Absentee ballots may be delivered at other times that are mutually agreed upon by the town clerk and registrars provided such time is not later than the close of the polls. (§ 9-140c)

<u>ELECTION DAY REGISTRATION.</u> Registrars of voters must designate a location for completing and processing EDR applications. The location must be one where registrars can access the statewide CVRS. No individual can be within 75 feet of the entrance to the EDR location or in any hallway or other approach to it to solicit support for, or opposition to, a candidate or ballot question. Registrars may appoint election officials to serve at the designated location. Individuals may register and vote in person on Election Day if they meet the eligibility requirements for voting in this state and are (1) not already an elector or (2) registered in one municipality but want to change their registration because they currently reside in another municipality. By law, a person is eligible to register and vote if they are (1) a U. S. citizen, (2) age 18 or older, and (3) a bona fide resident of the municipality in which they apply for admission as an elector.
